SESSION INFORMATION

The ice time is sold by yearly subscription. Because our ice sessions fill quickly, purchase your subscription soon to guarantee a spot. Please note that the Tuesday & Thursday Sessions are full year subscriptions and by signing up you are **required to pay for the 2019/2020 Subscription Contract**. You may pay in 3 installments.

We limit the number skaters on each session for purposes of skater safety. Sessions are also restricted to skating level (see table above). If necessary, adjustments may be made at the Rye FSC Board's discretion. If more than the allotted number of skaters applies for any session, some skaters may not receive a spot. You will be notified if the session is filled. Ice subscriptions are awarded as follows:

Applications postmarked by the deadline of **August 1st**.

- 1) Home Club Members: Prior Subscribers
- 2) Home Club Members
- 3) Associate Members: Prior Subscribers
- 4) Associate Members
- 5) Space permitting, any applications postmarked after August 1st

Walk-ons may be honored **only if space is available**. If the session is completely subscribed, walk-ons **will not** be permitted. The **walk on rate is \$35 per hour**. If available, walk ons will be sold on a first-come, first-served basis in 1- or 2-hour blocks. Any walk-ons must be cleared with the session monitor at the rink before the skater takes the ice.

COACHES

All coaches previously approved to teach on Rye FSC subscription ice must complete the annual USFS Coach Compliance. Coaches should submit their liability insurance forms to the attention of the Rye FSC Session Administrator at the address below or email the forms to ryesubice@gmail.com Any coaches who would like to begin teaching on the Rye FSC subscription ice **must** receive prior approval from the Rye FSC Board of Directors. To be considered for teaching on these sessions, coaches must submit their resume and liability insurance certificates to the attention of the session administrator at the address below and allow 2 weeks for Board approval.

MEMBERSHIP

You **must** be a Home Club or Associate Member of the Rye FSC to skate on the Rye FSC sessions. Membership forms are available on the Rye FSC website at www.ryefsc.com. Please note you will not be allowed to skate on a session unless your membership is current and any past due fees are paid.

SUBSCRIPTION PAYMENTS

Subscription payments for the 2019/20 skating season should be remitted as instructed on the subscription form. An Installment Plan is available with the **payment due dates listed on page 1**. Please mark your calendars with these dates. It is not the responsibility of the Club to remind you. No skater will be allowed to skate unless his/her account is in good standing. There is a 10 day grace period for all payments, after which time skaters whose accounts are past due will not be allowed on the ice, regardless of scheduled lessons. Failure to keep an account current will result in the skater being excused from a session and their spot sold to another skater. Returned checks will incur a fee of \$25.00.
